WHEREAS, the Governor of the State of California in cooperation with the California State Legislature has enacted State of California **Greenhouse Gas Reduction Funding**, which provides funds to the State of California and its political subdivisions for **forest health programs**; and

WHEREAS, the State Department of Forestry and Fire Protection (CAL FIRE) has been delegated the responsibility for the administration of the program within the State, setting up necessary procedures governing application by local agencies, non-profit organizations, and others under the program, and

WHEREAS, said procedures established by the State Department of Forestry and Fire Protection require the applicant to certify by resolution the approval of application before submission of said application to the State; and

WHEREAS, the applicant will enter into an agreement with the State of California to carry out a forest health project;

NOW, THEREFORE, BE IT RESOLVED that the CALAVERAS COUNTY RESOURCE CONSERVATION DISTRICT:

- 1. Approved the filing of an application for **"State Greenhouse Gas Reduction Funding"** forest health grant program funds; and
- 2. Certifies that said applicant has or will have sufficient funds to operate and maintain the project; and,
- 3. Certifies that funds under the jurisdiction of CALAVERAS COUNTY RESOURCE CONSERVATION DISTRICT are available to begin the project.
- 4. Certifies that said applicant will expend grant funds prior to March 31, 2030
- 5. Appoints Board President or a designee, agent of the CALAVERAS COUNTY RESOURCE CONSERVATION DISTRICT to conduct all negotiations, execute and submit all documents including, but not limited to applications, agreements, amendments, payment requests and so on, which may be necessary for the completion of the aforementioned project.

# **2025 – 2029 STRATEGIC PRIORITIES**

During the next five years, the Calaveras County Resource Conservation District (CCRCD) will commit to conserving, improving and sustaining the natural resources, environment and economy of Calaveras County. We will assist our conservation partners in ways that will benefit our CCRCD Cooperators and landowners. The CCRCD has recognized three strategic issues that it will focus on over the next four years.

Strategic Issue #1: Enhance the RCD's capability to implement its mission through continuous improvements in outreach, operations, and the visibility of the RCD.

#### **Goal #1: Improve community relations with agencies, non-profits, county program leads and the public to address resource concerns.**

**Desired Result #1**: Facilitate partnerships to address county resource concerns.

- Strategies to achieve the above result:
  - 1. Coordinate with County programs and departments to identify resource concerns and potential projects.
  - 2. Coordinate with local and state fire protection services to identify priorities.
  - 3. Coordinate with private and public landowners to identify project sites.

**Desired Result #2:** Leverage partnerships to accomplish work through shared goals. Strategies to achieve the above result:

- 1. Secure funding for projects through joint grant applications.
- 2. Develop a working plan for resource management needs.
- 3. Connect natural resource based management to economic opportunities in forest health, rangeland improvement, agriculture and tourism.

# **Goal #2: Increase the visibility of ESRCD within the community.**

Desired Result #1: Increased level of strategic outreach and networking.

Strategies to achieve the above result:

- 1. Creation of an Outreach Plan
- 2. Create branding materials with trainings for staff and board members on
- 3. Present at local city government, school boards, community groups
- **Desired Result #2:** Increased community awareness of ESRCD projects, programs and events. Strategies to achieve the above result:
  - 1. Develop educational program for natural resource concerns in Calaveras County.
  - 2. Creation of Outreach Calendar with points of engagement
  - 3. Attend community-based meetings for information and networking

**Desired Result #3:** Increased engagement of stakeholders through outreach programs. Strategies to achieve the above result:

- 1. Engage stakeholders at point of contact regardless of project
- 2. Distribute regular RCD correspondence (website, social media, newsletter, etc)
- 3. ESRCD presentations/info booths at partner organization events

Strategic Issue #2: Develop programs that address resource priorities and aid stakeholders in conservation practices through technical assistance, educational events, and demonstrations.

#### <u>Goal #1: Increase staff capacity to provide technical assistance and develop conservation</u> plans for resource management.

**Desired Result #1:** Increased staffing and technical knowledge to support efficiency. Strategies to achieve the above result:

- 1. Creation of Operational Plan for programs
- 2. Improved Organizational Structure to include growth strategy
- 3. Job Descriptions updated to include duties with Responsible, Accountable, Informed and Consulted designations

**Desired Result #2:** Provide training opportunities for staff and board members. Strategies to achieve the above result:

- 1. Secure opportunities for paid and free training to provide technical assistance
- 2. Educate staff and board members on NEPA/CEQA compliance
- 3. Provide incentives for staff to seek certifications and professional accolades

#### **Goal #2: Expand programs addressing climate resiliency benefiting conservation.**

**Desired Result #1**: Increase options for addressing fire resiliency

Strategies to achieve the above result:

- 1. Promote continued fuels reduction projects
- 2. Develop forest health conservation programs
- 3. Promote and expand air quality and fire safe programs
- 4. Develop defendable space programs for private landowners

**Desired Result #2:** Development of education programs for stakeholders to improve awareness of best management practices for carbon sequestration and GHG reduction. Strategies to achieve the above result:

- 1. Provide education through conservation workshops
- 2. Provide volunteer opportunities through conservation projects and programs
- 3. Identify community projects to participate and promote
- 4. Plan field days to demonstrate value of conservation programs

Strategic Issue #3: Encourage partnerships between stakeholders, organizations, regional entities and the CCRCD to develop projects that address resource priorities and produces data for conservation

#### Goal #1: Increase partnerships through outreach, projects, and programs

**Desired Result #1:** Increased participation in conservation programs.

Strategies to achieve the above result:

- 1. Partner with other organizations that have target audience
- 2. Host educational workshops on programs
- 3. Advocate for land management of natural resources

**Desired Result #2:** Develop educational programs that engage young adults and community members in conservation.

Strategies to achieve the above result:

- 1. Partner with education institutions to recruit participants.
- 2. Develop a demonstration project that is accessible to community members

#### Goal #2: Increase regional projects that engage with local and regional partners.

**Desired Result #1:** Increased RCD involvement in data collection and dissemination to support implementation of conservation practices in the Central Sierra.

Strategies to achieve the above result:

- 1. Develop watershed program that brings together regional partners to support forest health, water management, and reforestation
- 2. Invite new partners in existing regional projects as feasible
- 3. Develop press releases on exiting regional projects for exposure to new partners

# PLAN IMPLEMENTATION

The Calaveras County RCD will create annual implementation plans to be adopted each year by the RCD Board of Directors to provide specific yearly strategies based on the programs and priorities set in place. Implementation is ultimately based on availability of funding, as strategies identified in this plan require revenue far beyond what is reliably available. Funds are sought from a variety of sources including State and Federal grant programs, agreements with local and regional government agencies, and general fundraising.

As a non-tax assessment-based RCD, all revenue is derived from grants and agreements with other organizations, each year. Several existing and pending grant agreements have been acquired to carry out a significant portion of this strategic plan. Some initiatives may also require donations from local organizations. In addition, the RCD is exploring other opportunities such as a Negotiated Indirect Cost Rate Agreement, fundraising events, and fee for-service work.
